Description of content: FSANZ has received an Application to amend Standard 1.5.2 – Food Produced using Gene Technology in the <i>Australia New Zealand Food Standards Code</i> to approve the use of food derived from genetically modified corn line 3272. Amylase modified corn line 3272 has been developed primarily for dry-grind ethanol production, and for cultivation in North America. However some may inadvertently enter the food supply. Food derived from this corn could enter the market in Australia as imported processed food.</p>

All applications to change the <i>Australia New Zealand Food Standards Code</i>, must be assessed in the context of the following objectives: (a) the protection of public health and safety; (b) the provision of adequate information relating to food to enable consumers to make informed choices; and (c) the prevention of misleading or deceptive conduct.</p>
