Further Advice on AHO Approval and Listing under the Notice

- Organisations are required by the Notices to meet specific criteria in order to be approved as an AHO. The organisations in the table above have met the criteria.
- Once approved, an AHO can carry out halal verification and certification services for product intended for export to any countries other than those specified in Annex 2 of the Notices.
- In order to be able to carry out halal verification and certification services for product intended for export to countries in Annex 2 of the Notices, the AHO must be specifically listed for those countries. Listing for those countries is subject to the AHO meeting the listing criteria specified in the Notices.
- Each AHO in Column 1 of the table above have met the criteria to be listed for Annex 2 countries in corresponding Column 4.
