CONTROLLED AREA NOTICE

NOTICE UNDER THE BIOSECURITY ACT 1993

SECTION 131 - CONTROLLED AREA, MOVEMENT CONTROLS AND PROCEDURES IN RESPECT OF FRUIT FLY - *Bactrocera tau*

Commencement

1. This Notice takes effect at 2:10pm on 22 January 2016.

Controlled Area Declaration

2. Pursuant to section 131(2) of the Biosecurity Act 1993, I hereby declare that the area described in Schedule 1 ("the Controlled Area") is the area that is controlled in order to:—
 - a. Enable the limitation of the spread of *Bactrocera tau*, being an unwanted organism under the Biosecurity Act 1993;
 - b. Minimise the damage caused by *Bactrocera tau*;
 - c. Protect New Zealand from an incursion of *Bactrocera tau*;
 - d. Facilitate the access of New Zealand products to overseas markets; and
 - e. Monitor risks associated with the movement of *Bactrocera tau* from parts of New Zealand where the *Bactrocera tau* status is unknown.

Notice of Movement Controls

3. Under section 131(3)(a) of the Biosecurity Act 1993, I hereby give notice that, except with the written permission of an inspector or authorised person appointed under the Biosecurity Act 1993, and in compliance with any conditions imposed by an inspector or authorised person -
 - a. Things listed in Schedule 3 that are in Controlled Area Zone A (Schedule 1) must not be moved outside Zone A; and
 - b. Things listed in Schedule 3 that are in the Controlled Area Zone B (Schedule 1) must not be moved outside Zone B; and
 - c. Things listed in Schedule 3 that are in Controlled Area Zone A (Schedule 1) must not be disposed of by putting out for collection by rubbish or recycling collectors.
4. Things listed in Schedule 3 may be moved into Controlled Area Zones A and B.
5. The movement controls do not apply to the activities listed in Schedule 4.

Schedule 1 Description of Controlled Area

The following areas are included in the Controlled Area and subject to this Notice:

Zone A

Controlled Area (Zone A) is the area within a 200 metre radius of a point in Browns Road, Manurewa Auckland, as defined in the map in Schedule 2.

Zone B

Controlled Area (Zone B) is the area within a 1.5 kilometre radius of a point in Browns Road, Manurewa, Auckland, as defined in the map in Schedule 2, but excluding Controlled Area (Zone A).

Specific Properties in Zone A

Where a property is bisected by the boundary of Zone A of the Controlled Area, the entire property shall be included from in the Controlled Area.

Specific Properties in Zone B

Where a property is bisected by the boundary of Zone B of the Controlled Area, the entire property shall be included in the Controlled Area.

Zone B

1. All hosts listed above.

3. Soil and planting medium attached to, or in the vicinity of, hosts-bearing trees.
4. Green waste that contains hosts as above.



Schedule 4 Activities Not Subject to Movement Controls

The following activities are not subject to the movement controls over the things listed in Schedule 3:

- (1) Movement of household waste from the Controlled Area (Zone B) by way of ordinary rubbish and recycling collections.
- (2) Movement of goods by vehicle through the Controlled Area (Zones A and B) on Great South Road, provided that:
 - (a) Transit begins and ends outside the Controlled Area (Zones A and B);
 - (b) No stops are made within the Controlled Area (Zones A and B); and
 - (c) The material described in Schedule 3 is transported in an enclosed vehicle.
- (3) Movement of goods by train through the Controlled Area (Zones A and B), provided that:
 - (a) Transit begins and ends outside the Controlled Area (Zones A and B); and
 - (b) The material described in Schedule 3 is not removed from the train within the Controlled Area (Zones A and B) at any time.
- (4) Movement of goods outside the Controlled Area by customers of Approved Retailers.

Material listed in Schedule 3 may be moved outside the Controlled Area (Zone B) if:

- (i) The person moving the goods:
 - (a) Has purchased the goods from an approved retailer and has an itemised receipt as proof of purchase; or
 - (b) Is delivering goods that have been purchased by another person from an approved retailer and has an itemised receipt as proof of purchase; and
- (ii) The goods purchased remain in the approved retailer packaging until they leave the Controlled Area.

“Approved retailers” are those retailers which have agreed and been directed to comply with biosecurity conditions on the movement of *Bactrocera tau* host material into and out of their premises.

Members of the public can identify approved retailers by a MPI notice displayed at the entrance to, or in a prominent position within, the retailer’s premises, or by viewing the list of approved retailers on the MPI website: www.mpi.govt.nz/tau-fly
