# Estimated fees for ACVM regulatory assessment of veterinary medicines (July 2019)

## Applications for Registration or Variation to Registration

## To register a trade name product or vary one or more conditions on a trade name product under section 9 of the ACVM Act:

Application fee is \$135.00 (exc GST) / \$155.25 (inc GST) plus an assessment charge of \$135.00/hour (exc GST) / \$155.25/hour (inc GST) after the first hour (see estimate of time below).

## Pre-screen of applications

Pre-screen is done to determine if all the information required (section 10 of ACVM Act) has been provided.

The fee is \$67.50 (exc GST) / \$77.63 (inc GST) plus an assessment charge of \$135.00/hour (exc GST) / \$155.25/hour (inc GST) after the first 30 minutes.

## Processing time for assessment

The regulatory timeline as set In the ACVM Act is **40 working days**.

Note: If there is a significant new risk profile or change in the risk profile, public consultation will take an additional 30 working days and incur an additional charge of approximately \$150.

## **Multiple applications**

If more than one application is submitted at the same time, the first application is charged as above and additional applications are charged on a cost versus time basis of \$135.00/hour (exc GST) / \$155.25/hour (inc GST).

## Estimate of time

Estimated time DOES NOT cover assessment of data prior to regulatory appraisal. For the Data Assessment Service fees refer to "ACVM fees and charges for regulated and discretionary services".

Estimates below are given as a range, as time for individual applications will vary depending on technical input required.

## Registration

The fee for registering a product or for changing a registration is \$405.00 (exc GST) / \$465.75 (inc GST). Registrations are valid for 5 years, or a shorter time period if required for risk management purposes.

### **Registration Renewals**

Registration renewals are charged out at cost v time based on the rate of \$135.00/hour (exc GST) / \$155.25/hour (inc GST)

### **Annual Fees**

Annual fees (defined as the levy in the ACVM (Fees, Charges, and Levies) Regulations, which are separate from registration fees are \$540.00 (exc GST) / \$621.00 (inc GST) per registered trade name product.

#### Disbursements

The following disbursements relating to applications to register a trade name product are payable by the applicant. These are charged at the actual cost:

- external review
- expert review
- notification
- postage
- product testing
- travel and accommodation.

## Processing time and fees for assessment

The regulatory timeline as set in the ACVM Act is **40 working days.** 

The rate is the same as applications for registration.
