

# Appoint a representative

## Climate Change Response Act (2002)

Use this form if you want to appoint a representative to act on your behalf in relation to the Climate Change Response Act 2002. This will allow your representative to do the following on your behalf:

- make enquiries
- sign documents
- give and receive notices
- submit applications
- access your data and information.

Appointing a representative is a serious matter that you should consider carefully. You are liable for ensuring your ETS obligations are met. This includes when someone is acting on your behalf. If something goes wrong, you could be penalised, fined, or prosecuted.

You can appoint more than one representative to your party, but you'll need to complete this process for each one. Your representatives should be aware that they may be able to see information about each other in our system.

#### 5 Signature of party appointing a representative

This needs to be signed by:

- one person who has authority in the party (such as a director, if it's a company), or
- both members, if you are joint applicants.

If you are an unincorporated body (such as a trust) and you aren't registered in the ETS yet, all members of the party must sign this form. However, if your trust deed states that one trustee may act on behalf of the trust, you can provide one trustee's signature only, along with a copy of the deed.

We need your consent to provide information about your participation in forestry in the ETS to the representative. The representative cannot carry out any activities on your behalf until you have met the signatory requirements on this form.
