## **CONTROLLED AREA NOTICE**

## NOTICE UNDER THE BIOSECURITY ACT 1993 (the Act)

# SECTION 131 - CONTROLLED AREA, MOVEMENT CONTROLS AND PROCEDURES IN RESPECT OF PEA WEEVIL (*Bruchus pisorum*)

#### Commencement

1. This Notice takes effect at 1:00pm on 17<sup>th</sup> February 2020.

#### **Controlled Area Declaration**

- 2. Pursuant to section 131(2) of the Biosecurity Act 1993, I hereby declare that the areas described in **Schedule 1** and defined by the map in **Schedule 2** ("the Controlled Area") are the areas controlled in order to:
  - a. Enable the limitation of the spread of *Bruchus pisorum*, being an unwanted organism under the Biosecurity Act 1993;
  - b. Minimise the damage caused by Bruchus pisorum; and
  - c. Facilitate the access of New Zealand products to overseas markets.

#### **Notice of Movement Controls**

- 3. Under section 131(3)(a) of the Biosecurity Act 1993, I hereby give notice that, except in accordance with any conditions imposed by this notice or as permitted by an inspector or authorised person:
  - a. Things listed in **Schedule 3** that are within the Controlled Area and that do not comply with the conditions in Schedule 4 must not be moved out of the Controlled Area.

Note: Things listed in Schedule 5 are not subject to any movement controls.

### Revocation of previous Controlled Area and Notice of Movement Controls

4. This Declaration and Notice revokes and replaces the Declaration of Controlled Area and Notice of Movement Controls issued on 11 August 2016 in respect of *Bruchus pisorum*.

## **Schedule 1 - Description of Controlled Area**

The following areas are included in the Controlled Area and are subject to this Notice:

All properties within or intersected by a five kilometre radius from the corner of Te Ore Ore Road, Masterton Castle Point Road and Te Ore Ore Bideford Road, being the Global Positioning System coordinate of -40.949720, 175.696003 or 40°56'59.0"S 175°41'45.6"E

The Controlled Area includes a portion of the Masterton District.

A map of the Controlled Area is included in Schedule 2.



# Schedule 3 - Things subject to Movement Controls (prohibitions)

The following things may not be moved out of the Controlled Area, except as allowed in Schedule 4.

- i. Feed peas and pea seeds (Pisum sativum) grown within the Controlled Area for commercial use; and
- ii. Pea Weevil (Bruchus pisorum), in any form.

# Schedule 4 - Permission to move things subject to Movement Controls

The following things in Schedule 3 may be moved out of the Controlled Area, subject to the below conditions:

- i. Feed peas and pea seeds (Pisum sativum) grown within the Controlled Area for commercial use, if:
  - a. Prior to sowing, Biosecurity New Zealand is informed where the pea seeds will be sown. Please contact Biosecurity New Zealand at <a href="mailto:Rory.MacLellan@MPI.govt.nz">Rory.MacLellan@MPI.govt.nz</a> or <a href="mailto:Priscila.Freitas@MPI.govt.nz">Priscila.Freitas@MPI.govt.nz</a>;
  - b. Three perimeter sweep net inspections of the sown peas are carried out by a Biosecurity New Zealand approved contractor during the flowering period;
  - c. The feed peas and pea seeds are cleaned and dressed at a facility within the Masterton area. The peas may be sent to any facility within the Masterton District (whether in the Controlled Area or not); and
  - d. A representative sample of the crop and the cleaning screenings must be soak tested by a Biosecurity New Zealand approved contractor.

MPI will assist you in organising compliance with these conditions on being alerted to your planned sowing.

## Schedule 5 - Things not subject to any movement controls

The following things may be moved into, within, and out of the Controlled Area without restriction:

- i. Peas processed and packaged for human consumption, including fresh, frozen, canned or dehydrated peas;
- ii. Pea plants;
- iii. Pea straw;
- iv. Home garden pea seeds; and
- v. Feed peas and pea seeds grown outside of the Controlled Area.

# **Important Information**

- 1. It is an offence under section 154N(8) of the Biosecurity Act 1993 to:
  - Move, direct or arrange the movement of any organisms, organic material, risk goods or other goods in contravention of this Notice.
  - Fail to carry out any treatments or procedures specified in this Notice.

Individuals may be liable under section 157(4) of the Biosecurity Act 1993 for a fine of up to \$50,000 or a term of imprisonment of up to 3 months or both. Corporations may be liable for a fine of up to \$100,000.
