1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

(i) the issue under section 60 of the export requirements for commercial birds to the United States of America BIRAVIEC2.US dated 17 March 2014;

(ii) the determination under section 62(1) of the format and content of the official assurance for commercial birds to the United States of America.

This notice takes effect from the 17th March 2014.

2. United States of America requirements

Commercial birds exported from New Zealand to the United States of America must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the commercial birds do not satisfy the conditions in the notice. Likewise, if the commercial birds do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

VETERINARY CERTIFICATE

I, , being an Official Veterinarian of the New Zealand Ministry for Primary Industries certify after due enquiry, in regards to the birds identified in this Zoosanitary Certificate that:

- 1. There has been no evidence of Newcastle disease, chlamydiosis, or other communicable disease of avians (poultry and birds) during the ninety (90) days immediately preceding their export from the premises of origin.
- 2. The premises where the birds were exported from were not adjacent to any areas under quarantine during the ninety (90) days preceding the exportation.
- 3. The birds have not been vaccinated against Newcastle disease.
- 4. The birds have not been vaccinated against any H5 or H7 subtype of avian influenza.
- The shipment will not transit through any regions where APHIS considers highly pathogenic avian influenza 5. to exist.
- 6. All birds covered by the certificate were examined on the day of export and were found to be clinically healthy and showed no evidence of avian communicable diseases.
- 7. The birds are being exported in accordance with IATA regulations and in accordance with New Zealand law.
- 8. The commercial birds were placed into previously unused containers at the premises of origin from which the export process began.

- **NOTES** This is a new export certificate based on the "protocol for the importation of commercial birds or poultry" of May 2013. This certificate was approved by the USDA on 25 February 2014.
- 1. The USDA defines commercial birds as those birds which are imported for resale, breeding, or public display. Ratites may not be imported under this protocol. Ratites are defined as: cassowaries, emus, kiwis, ostriches and rheas.
- 2. USDA makes a distinction between birds and poultry. Avian species defined as poultry include: chickens, doves, ducks, pigeons, geese, grouse, guinea fowl, partridges, pea fowl, pheasants, quail, swans, turkeys and eggs for hatching. These are not considered to be commercial birds.

- 4. All commercial birds imported into the United States (except from Canada) are required to be quarantined for a minimum of 30 days, or longer if required by the Administrator.
- 5. Commercial bird quarantines must take place at one of the USDA facilities listed in the table below, or may occur in a privately owned quarantine facility that has been approved by APHIS.

- 6. The importer must contact a USDA port veterinarian or a USDA Animal Import Centre no later than 3 business days in advance of arrival of the bird(s) to coordinate the import process.
- 7. In the United States, the U.S Fish and Wildlife Service (FWS) regulates the importation of birds protected by the Convention on International Trade in Endangered Species (CITES) and the Wild Bird Conservation Act of 1992 (WBCA). These regulations are part of an international conservation effort to protect exotic wild birds subject to trade. Most exotic pet birds (including psittacines such as parrots, parakeets, macaws, lories, and cockatoos), and some poultry species, are affected by CITES and the WBCA. However, the budgerigar, cockatiel and rosy-faced lovebirds are exempt.

- 9. In reference to clause 1 in the export certificate the disease freedom statement refers to the premises of origin of the bird(s).
- 10. In reference to clause 2 in the export certificate, 'areas under quarantine' refer to areas under movement restrictions due to avian disease outbreaks.

- 12. A current veterinary health certificate, issued within thirty (30) days of importation, must accompany each shipment of commercial birds. The certificate which accompanies the bird must be the original.

Section 61A of the Animal Products Act 1999 states that 'The Crown is not liable, and nor is the Director-General or any employee of the Ministry liable, for any loss arising through the refusal or failure of the relevant authority of an overseas market to admit export animal material or animal product to that market.'
