Consultation on proposed new Animal Products Notice:

The Ministry for Primary Industries (MPI) proposes to amend the Animal Products Notice: Dairy Recognised Agencies and Persons Specifications.

The Notice specifies the procedures and requirements for the recognition of agencies and persons.

The proposed amendments are intended to provide:

- (i) a process for the recognition of persons as raw milk farm dairy assessors and responsible verifiers under the Raw Milk for Sale to Consumers Regulated Control Scheme. This is necessary in order to ensure that appropriate recognised persons are available to fulfil the functions required under the Raw Milk for Sale to Consumers Regulations 2015 and the Animal Products Notice: Raw Milk for Sale to Consumers;
- (ii) correction of some technical errors in the Notice; and
- (iii) further clarification of the courses for dairy heat treatment. Successful completion is a competency requirement for persons initially applying for recognition as a risk management programme verifier for manufacturing product groups that include heat treatment.

MPI will be reviewing other areas related to this Notice in 2017 and will consult on any proposed amendments in due course.
