1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

(i) the issue under section 60 of the overseas market access requirements for dogs and cats to the Falkland Islands PETANI.FK dated 12 April 2017;

(ii) the revocation and replacement of dogs and cats to the Falkland Islands PETANI.FK dated 17 February 2017;

(iii) the determination under section 62(1) of the format and content of the official assurance for dogs and cats to the Falkland Islands.

This notice takes effect from the 12th of April 2017.

2. Falkland Islands requirements

Dogs and cats exported from New Zealand to the Falkland Islands must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the dogs and cats do not satisfy the conditions in the notice. Likewise, if the dogs and cats do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

6. IN THE CASE OF A DOG ONLY*:

6.1 The dog(s) was (were) fully vaccinated against rabies, distemper, infectious hepatitis, leptospirosis, parvovirus and kennel cough (both parainfluenza and bordetella (intranasal)), not less than thirty (30) days and not more than twelve (12) months prior to the proposed date of export. In the case of vaccinations with period of validity longer than twelve (12) months, it was done in accordance with manufacturer's instructions. - **NOTES:** This certificate is based on the requirements for importation of cats and dogs from New Zealand to the Falkland Islands. It replaces the certificate dated 17 February 2017. The certificate was approved by Falkland Islands in April 2017.
- 1. An import permit is required from the Veterinary Service, Department of Agriculture, Falkland Islands.
- 2. This certificate is valid for embarkation for forty-eight (48) hours from the date of signature. The period of validity is then extended for the duration of the journey.
- 3. The certificate must be signed and stamped by an official veterinarian at the port of departure.
- 4. Animals must be inserted with a microchip prior to prior to testing and certification.
- 5. Original laboratory reports or certified copies must accompany the export certificate.
- 6. Clause 7.2 and 7.3 these tests are currently unavailable at an approved government laboratory within New Zealand. Samples will need to be sent to an overseas laboratory. Please contact the MPI Animal Health Laboratory for more information.
- 7. Only cats giving a negative result to the feline leukaemia and feline infectious peritonitis (coronavirus) test, will be allowed entry into the Falkland Islands. Due to the insensitivity of the test to FIP specific coronavirus, in the event of a positive test, the Veterinary Service, Falkland Island Government will need to be contacted, for further evaluation.
- 8. The animal must not be more than twenty-eight (28) days pregnant at the time of export.
- 9. A copy of the certificate must be faxed/or scanned/emailed to the Practice Manager, Falklands Islands Government Veterinary Service, immediately on completion. Email: <u>sbowles@doa.gov.fk</u> Fax: 00 500 27352. Tel: 00 500 27366. The original completed export certificate should accompany the animal.
- 10. If the container is opened during shipment, it must be resealed and a certificate issued detailing the seal number and the circumstances, provided by an Official Veterinarian, official of the port authority, or Captain of the aircraft. An instruction to this effect in English and Spanish must be affixed to the outside of the transport container.
- 11. The importer must inform the Veterinary Service, Department of Agriculture prior to the disembarkation of the animal(s).
- 12. Upon arrival in the Falkland Islands all animals:
 are required to undergo a forty-eight (48) hour period of house quarantine (at the Veterinary Officer's discretion)
 will be examined and have repeat flea and worming treatments administered after two (2) weeks.

Section 61A Animal Products Act 1999 states that 'The Crown is not liable, and nor is the Director-General or any employee of the Ministry liable, for any loss arising through the refusal or failure of the relevant authority of an overseas market to admit export animal material or animal product to that market'.
