Winter Grazing Action Group

TERMS OF REFERENCE

Purpose

• Implement the recommendations applicable to the Action Group, as outlined in *Improving* animal welfare on winter grazing systems, report, that was prepared by the Intensive Winter Grazing Taskforce, and released by Minister O'Connor on 25 November 2019.

Principles

- Discussions held by the Action Group may be shared outside of meetings provided individual comments are not attributed. Members are encouraged to communicate with their peers/membership to keep them informed, seek feedback or to progress actions.
- The Ministry for Primary Industries will publish meeting summaries and key documents on its website, and these notes can be discussed freely outside of meetings. Within published documents no comments will be attributed to any individuals of the group.
- Members work together as a team and will be free and frank with information and advice, whilst being respectful of each other's views. Where possible decisions will be taken on a consensus basis.
- The Chair will report to the Minister of Agriculture, however if appropriate, the Chair may escalate issues to;
 - The Chair of the Winter Grazing Taskforce
 - The DGG Agriculture & Investment Service
 - The DG Ministry for Primary Industries

Expectations for work delivery

- The recommendations outlined in the Winter Grazing Report developed by the Taskforce will be progressed
- Develop an overview of winter grazing systems including parties that influence farm decisions, , which identify the decision points and behavioural drivers at each step of the process, and work to develop an extension and communication approach to encourage the right behaviour at the right time.
- A plan will be agreed that identifies the actions required to achieve the recommendations, using the system map to focus & prioritise resources. The plan will focus on the deliverables and will include key milestones.
- Encourage the primary sector to act on recommendations which will require support from businesses & organisation outside of the Action Group to fully achieve.
- Progress reports will be published on the Ministry for Primary Industries website. Where recommendations are unable to be implemented within expected timeframes, or, following further analysis, are unfeasible to achieve, this will be identified.

- The Terms of Reference may be reviewed from time to time to maintain relevancy. Any changes made will require consensus from the Action Group.
