To Whom it May Concern

The Ministry for Primary Industries upgraded their electronic platform for the generation of export documentation for New Zealand grape wine in October 2014. Export Certificates issued after the 20th of October 2014 are generated from this new platform known as Wine E-Cert.

The format of the Export Eligibility Statement, generated for the purpose of confirming to New Zealand customs that a consignment of wine is eligible for export, has been modified. A specimen copy of an Export Eligibility Statement generated from Wine E-Cert is provided on the following page. The statement now includes details of the freight forwarder and the numbering format has been modified. An example of the new and old numbering format is as follows:

Note: Export Eligibility Statements are not intended to be a document for clearance purposes for the importing country.

The numbering system for batches and samples in Wine E-Cert has also changed. These numbers may appear on analysis reports generated by laboratories recognised for testing of wine for export. Examples of the new and old numbering format are as below:

	<u>New format</u>	<u>Old format</u>
Wine batches (created before 20 October 2014)	SC/14/12345	SC12345
Wine batches (created after 20 October 2014)	WB/14/12345	
Wine samples	WTR14X123	WT12345

In all the examples above "14" indicates the calendar year of creation.
