OMARs with an uncertain status

These OMARs have not been used for a significant period of time. Therefore the requirements may have changed without the Ministry for Primary Industries knowledge.

If an exporter can provide the current import conditions, and the requirements still match, the certificate and the OMARs will be moved back into the published list of export certificates and OMAR's.

1. Statutory authority

Pursuant to section 60 of the Animal Products Act 1999, I notify the following overseas market access requirements, entitled Horses to Samoa.

2. Samoan Requirements

Horses exported from New Zealand to Samoa must comply with the import regulations of Samoa listed in this notice as follows.

- 2.1 An official veterinarian authorised by the New Zealand Ministry of Agriculture and Forestry must certify after due enquiry the following:
 - 2.1.1 After due enquiry, they have no reason to doubt the exporters declaration.
 - 2.1.2 New Zealand is free from the following diseases:

African horse sickness, Equine encephalomyelitis (Eastern, Wetsern, Venezuelan), Borna disease, Vesicular stomatitis, Dourine, Epizootic lymphangitis, Rabies, Contagious equine metritis (CEM), Equine influenza, Equine piroplasmosis, Equine salmonellosis (*Salmonella abortus equi*), Horse pox, Glanders and Surra.

- 2.1.3 The horses were treated with a broad-spectrum anthelmintic and external parasiticide, in accordance with the manufacturer's recommendations. (date of treatment, product/s, dose rate/s).
- 2.1.4 The horses were examined within three days of the scheduled date of export and were found to be healthy, free from signs of infectious and contagious diseases including ectoparasites (especially ticks), and fit to travel.
- 2.2 The exporter must sign a declaration that:
 - 2.2.1 The horse/s for export have been resident in New Zealand since birth or for at least the previous 3 months.
 - 2.2.2 During the 3 month period prior to the scheduled date of export the animals have shown no clinical signs of infectious or contagious diseases, and the animals have not come into contact with infectious or contagious diseases.

3. Definitions

For the purposes of this document:

Any term or expression that is defined in the Animal Products Act 1999 and used, but not defined in this document, has the same meaning as in this Act.

Explanatory note:

These overseas market access requirements are drafted on the current export certificate for the exportation of Horses to Samoa dated 18 August 2004.

An import permit is required for importation.
