### **FISANIEC.IL 21 AUGUST 2013 – ORNAMENTAL FISH TO THE STATE OF ISRAEL**

#### **1. Statutory authority**

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the export requirements for ornamental fish to the State of Israel FISANIEC.IL dated 30 August 2013;
- (ii) the determination under section 62(1) of the format and content of the official assurance for ornamental fish to the State of Israel

This notice takes effect from the 30<sup>th</sup> August 2013.

#### **2. Israel requirements**

Ornamental fish exported from New Zealand to the State of Israel must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

#### Explanatory note:

If the zoosanitary certificate is not certified then the ornamental fish do not satisfy the conditions in the notice. Likewise, if the ornamental fish do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

I, ....., the undersigned Official Veterinarian of the New Zealand Ministry for Primary Industries, hereby certify that the animals forming the present consignment:

- A. Have originated from a controlled establishment which is under regular veterinary control.
- B. Have originated from an establishment in which no cases of Spring Viremia of Carp (SVC) or other viral diseases have been recorded during the last two years.
- C. Have originated from a farm which is not in contact through the water with other farms affected by virus.
- D. Have originated from a farm whose sales have not been prohibited by sanitary regulations and have not been in contact with other fish coming from such farms.
- E. Originate from a farm in which no clinical signs of disease were observed when the said consignment of fish was conditioned for shipping.
- F. This certificate has been issued within 48 hours before shipment and is valid for 10 days.

## EXPORT CERTIFICATION

**NOTES:** This is a new certificate and is based on a fish import permit and model health certificate from the State of Israel dated 30 June 2013. This certificate was approved by Dr Z Avni (Ben Gurion Airport Quarantine Station Chief Veterinary Officer), Veterinary Services and Animal Health, Ministry of Agriculture and Rural Development, State of Israel on 18 August 2013.

1. An Import Permit is required.
2. This certificate is for fish and fish gametes/eggs/embryos, including those from research laboratories.
3. The Veterinary Services office in Ben-Gurion Airport (Phone 972-3-9792240, Fax 972-3-9772033) must be notified as to the time of the shipment delivery and flight details at least 48 hours before its arrival.
4. A shipment can only be released from the port upon Veterinary Services permission.

**Section 61A of the Animal Products Act 1999 states that 'The Crown is not liable, and nor is the Director-General or any employee of the Ministry liable, for any loss arising through the refusal or failure of the relevant authority of an overseas market to admit export animal material or animal product to that market'.**
