1. Statutory authority

Pursuant to section 60, section 60A, section 62(1) and section 167 of the Animal Products Act 1999 I notify the following:

- (i) the issue under section 60 of the export requirements for sheep and goats to Taiwan SAGANIEC.TW dated 21 December 2012;
- (ii) the determination under section 62(1) of the format and content of the official assurance for sheep and goats to Taiwan.

This notice takes effect from the 21st of December 2012.

2. Taiwan requirements

Sheep and goats exported from New Zealand to Taiwan must be accompanied by an official assurance in the form of a completed zoosanitary certificate.

The zoosanitary certificate as specified below must be completed and certified, after due enquiry, by an Official Veterinarian of the Ministry for Primary Industries.

Explanatory note:

If the zoosanitary certificate is not certified then the sheep and goats do not satisfy the conditions in the notice. Likewise, if the sheep and goats do not satisfy the zoosanitary requirements in the certificate, then the certificate will not be certified.

VETERINARY CERTIFICATE

I,, an Official Veterinarian of the New Zealand Ministry of Agriculture and Forestry, hereby certify, after due enquiry with respect to the animals identified in this Export Certificate, that:

1 Country freedom

1.1 New Zealand is free from African swine fever, bluetongue, *Brucella abortus*, *Brucella melitensis*, contagious bovine pleuropneumonia, enzootic abortion of ewes (*Chlamydophila abortus*), foot-and-mouth disease, haemorrhagic septicaemia, *Leptospira canicola*, *L. icterohaemorrhagiae*, maedi-visna, melioidosis, peste des petits ruminants, rinderpest, sheep scab (*Psoroptes ovis*), sheep and goat pox, and vesicular stomatitis.

Vaccination against foot and mouth disease and rinderpest is prohibited in New Zealand.

- 1.2 In accordance with the OIE *Code* recommendations, New Zealand has been free from foot-and-mouth disease, bluetongue, brucellosis (*Brucella abortus* and *B. melitensis*), and vesicular stomatitis for at least 5 years.
- 1.3 In accordance with the recommendations in Article 14.9.3 of the OIE *Code*, New Zealand has been free from scrapie for at least 7 years.

2 Premises of origin

- 2.1 The animals originate from establishments that have been free from scrapie for at least 7 years.
- 2.2 The animals originated from flocks of origin that have not had any confirmed cases of the following diseases for the specified time periods prior to the scheduled date of export:
 - 2.2.1 ovine epididymitis (*Brucella ovis*), sheep mange (*Psoroptes ovis*, *Sarcoptes scabiei*, *Chorioptes bovis*, *Demodex ovis and Demodex caprae*, *Psorergates ovis*), bovine tuberculosis, and paratuberculosis (Johne's disease) for at least 1 year.
 - 2.2.2 contagious pustular dermatitis, leptospirosis, campylobacteriosis/vibriosis (*Campylobacter fetus fetus*), and listeriosis for at least 6 months.

3 Testing and vaccination

3.1	During the period 90 to 60 days prior to the scheduled date of export the animals were tested with negative results for bovine tuberculosis, using the intradermal tuberculin test using bovine PPD. The testing interval between this test and any previous test was longer than 60 days.

acceptable was received in an email from BAPHIQ on 22 November 2012.

- 1. An Import Permit is required.
- 2. All animals must be accompanied by the original export certificate in English issued by the Ministry of Agriculture and Forestry.
- 3. No feed, fodder, bedding, or other animals shall be supplementary loaded during transportation. The transportation and transition shall follow the Terrestrial Animal Health Code of the OIE and regulations of the IATA.
- 4. Animals must not be transhipped through countries or zones where foot-and-mouth disease, rinderpest or contagious bovine pleuropneumonia is known to occur.

Section 61A of the Animal Products Act 1999 states that 'The Crown is not liable, and nor is the Director-General or any employee of the Ministry liable, for any loss arising through the refusal or failure of the relevant authority of an overseas market to admit export animal material or animal product to that market'.
