<p>Seed for sowing – <i>Capsicum</i> (all <i>Capsicum</i> species); <i>Solanum</i> (all <i>Brugmansia</i> species, <i>Solanum jasminoides</i>, and <i>Physalis peruviana</i>)</p> <p>Nursery stock – <i>Chrysanthemum</i> (all <i>Argyranthemum</i> and <i>Chrysanthemum</i> species); <i>Dahlia</i> (all <i>Dahlia</i> species); <i>Diascia</i> (all <i>Diascia</i> species); <i>Solanum</i> (all <i>Browallia</i>, <i>Brunfelsia</i>, <i>Calibrachoa</i>, <i>Cestrum</i>, <i>Fabiana</i>, <i>Lochroma</i>, <i>Nierembergia</i>, <i>Petunia</i>, and <i>Scopolia</i> species)</p> <p>These pathways, along with those already listed in the standard (<i>Solanum tuberosum</i> true seed and nursery stock, <i>Solanum lycopersicum</i> seed, and <i>Persea</i> spp. nursery stock), must now meet the Ministry for Primary Industries requirements for PSTVd as specified in the relevant import health standard.</p>
